ANY EXCEPTIONS MUST BE AGREED UPON IN ADVANCE. NEITHER PORTLAND INT. RACEWAY NOR CHRIS EVANS INC WILL BE RESPONSIBLE FOR ITEMS LEFT AFTER 7:00PM SUNDAY, JULY 18, 2010 WITHOUT PRIOR ARRANGEMENT.

SOUND LEVELS

THE EXHIBITOR AGREES TO RELEASE THE NAMED ASSOCIATION, PARTIES, INDIVIDUALS, AND EMPLOYEES FROM ANY AND ALL CLAIMS FOR SUCH LOSS, DAMAGE, OR INJURY.

PROOF OF THIS INSURANCE IS REQUIRED BEFORE THE OPENING OF THE EVENT. INSURANCE CERTIFICATE SHALL LIST PORTLAND INTERNATIONAL RACEWAY, THE CITY OF PORTLAND, NASCAR, AND CHRIS EVANS, INC AS ADDITIONAL INSURED.
